The undersigned Applicant (also meaning Joint Applicant if any) hereby applies for membership in, and agrees to purchase firm electric power and energy from Prince George Electric Cooperative (Cooperative) and to be bound by the Cooperative's Terms and Conditions for Providing Service and the following provisions:

1. Applicant will pay a \$5.00 non-refundable membership fee, unless a membership fee exists for another active account of the applicant.
2. A 20.00 non-refundable activation fee will be paid to process the service request if manual site visit.
3. The Applicant will be bound by the Cooperative's By-Laws and Terms and Conditions for Providing Service (as approved by the Virginia State Corporation Commission) and such rules and regulations as may be adopted from time to time by the Cooperative.
4. The Cooperative may require the electric service agreement and account be in the name(s) of the lessor(s) on a valid and current lease on the premises.
5. The Applicant hereby gives the Cooperative consent to inquire of the Applicant's record with any credit reporting agency or other organization for verification of any data supplied by the Applicant; determination of the credit worthiness and risk of collection of any amounts owed by the Applicant; or any other purposes necessary for carrying out this contractual agreement.
6. The Cooperative may require initially or at any time, a security deposit to insure collection of amounts billed for services. The amount of the security deposit required, may be equal to the two highest month bills in a twelve- month period (or as allowed by the Virginia State Corporation Commission). The amount of the security deposit may be adjusted at any time the Cooperative determines the Applicant's payment record or other facts indicate a risk of collection of bills for services delivered. **Security Deposit: Paid \$ _____ to Bill \$ _____**
7. By paying a membership fee and becoming a member of the Cooperative, the Applicant assumes no personal liability or responsibility for any debts or liabilities of the Cooperative.
8. The Applicant will cause his premises to be wired in accordance with wiring specifications of all federal, state, or local authorities having jurisdiction over the wiring of electrical equipment. The Applicant will have the installation properly inspected by local authorities in accordance with local ordinances.
9. When electric energy becomes available, the Applicant will purchase from the Cooperative, all electric energy used on the premises and will pay therefore monthly at the rates and fees established from time to time in accordance with the Cooperative's rate schedules and Terms and Conditions for Providing Service and any duly executed contracts or agreements. The electric service will not be used for standby or backup purposes.
10. The Applicant authorizes the deduction from the Applicant's equity in the assets of the Cooperative, a sum equal to the annual subscription rate as payment for Applicant's subscription to the Cooperative Living magazine or other such publication used for communication with the members of the Cooperative.
11. The Cooperative shall have a the right of access to the Customer's premise at all reasonable times for the purpose of reading meters of the Cooperative, maintaining, testing, removing its property, or for other proper purposes, and the Cooperative shall have the right to discontinue the supply of electricity without notice if such access at any time is denied representatives of the Cooperative.
12. The Applicant agrees to allow the Cooperative to utilize the Applicant's telephone line for communication with the Cooperative's metering and other device(s) situated on the Applicant's premises.
