The undersigned (hereinafter called the "applicant") hereby applies for membership in, and agrees to purchase firm electric power and energy from, Prince George Electric Cooperative, (hereinafter called the "Cooperative") and be bound by the Cooperative's Terms and Conditions of Service:

1. Applicant will pay to the Cooperative the sum of \$5.00 dollars which will constitute the Applicant's membership fee unless a membership fee already exists on file.
 2. A \$30.00 non-refundable activation fee will be paid to process the service request.
 3. Applicant will, when electric energy becomes available, purchase from the Cooperative all electric energy used on the premises described below and will pay therefor monthly at rates and fees determined from time to time in accordance with the By-laws and Terms and Conditions of Service of the Cooperative and duly executed contract. The electric service will not be used for standby purposes.
 4. The Applicant will cause his premises to be wired in accordance with wiring specifications approved by the Cooperative, in conjunction with any Federal, State, or Local Regulations.
 5. The Applicant will comply and be bound by the provision of the certificate of incorporation and By-laws of the Cooperative's Terms and Conditions of Service, and such rules and regulations as may from time to time be adopted by the Cooperative.
 6. The Applicant authorizes the deduction from the Applicant's equity in the assets of the Cooperative a sum equal to the annual subscription rate as payment for the Applicant's subscription to the Cooperative Living magazine or other such publication used for communication with the members of the Cooperative.
 7. The Applicant hereby gives the Cooperative consent to inquire of the Applicant's record with any credit reporting agency or other organization for verification of any data supplied by the Applicant; determination of the credit worthiness and risk of collection of any amounts owed by the Applicant; or any other purposes necessary for carrying out this contractual agreement.
 8. The Applicant, by paying a membership fee and becoming a member assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law his private property cannot be attached for any such debts or liabilities.
 9. The Cooperative shall have the right of access to the Customer's premises at all reasonable times for the purpose of reading the Cooperative's meter, maintaining, testing, removing it's property, or for other proper purposes, and the Cooperative shall have the right to discontinue the supply of electricity without notice if such access at any time is denied to a representative of the Cooperative.
 10. The Applicant authorizes the Cooperative to contact provided contact listings for purposes of establishing credit and security. The Applicant also agrees to let the Cooperative access credit rating agencies for purposes of validating provided information but not to be used as a device or means to establish a credit score.
 11. The Cooperative may require initially or at any time, a security deposit to insure collection of amounts billed for service. The amount of the security deposit required may be equal to the two highest month bills in a twelve month period (or as allowed by the Virginia State Corporation Commission). The amount of the security deposit may be adjusted at any time the Cooperative determines the Applicant's payment record or other facts indicate a risk of collection of bills for services delivered.
- The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, for the contract of electric service.*
